California Longitudinal Pupil Achievement Data System [CALPADS] Overview



CALPADS



- Collects student enrollment, demographic, program participation, course enrollment and completion, discipline, certificated staff, and attendance data
 - Data is updated throughout the year as students enroll and exit
 - Data is used to track students over time
 - Fulfill state and federal reporting requirements
- Data reported in CALPADS are used for funding, accountability, and research
- Provide information about students and schools to state decisionmakers, parents, community and researchers



The following file types comprises the **Student Profile**.




Reporting the Student enrollment gives you ownership of the SSID and allows submission of the rest of the student data.

Student Profile Data for Fall 1



***Any student who qualifies in any of the criteria are entitled to free or reduced price lunch.**

Education Program Code:

181 (Free) 182 (Reduced Price)

Program Start Date: Must be in the current academic year for each reporting year. The date an approved NSLP meal application was received*.

Program End Date: Represents the date that the student exited the school for the academic year** reduced price lunch.

*NSLP applications received on or before 10/31/2023 will be included in the LCFF Reports.

**FRPM records for enrollment records exited with a code other than E150 will be auto-closed by CALPADS.



How to Prepare Data for Submission

- Step 1: Enter required data fields into the SIS
 - Required Data: Student Demographics and Information, Student Programs, ELA Status
 - Special Ed data from Special ED SIS
- Step 2: Check data for completeness
 - Exception reports are shared with the school to populate data where needed
- Step 3: Submits completed reports to CALPADS
 - Checks data against previous year's data to identify anomalies for additional school review.
- Step 4: Records are committed to CALPADS
 - Certify the data with client approval
